Ms. Johnson:

James Edwards of the Law Department requested that I provide you with information regarding the City of Detroit's collection of unclaimed funds that are being held by the State of Michigan.

I filed a claim for the collection of the funds. The claim number is 803958. There are approximately 700 accounts under this claim for various City departments. The total estimated refund is \$354,956.17.

The State responded and requested additional documentation for specific accounts and information in general about the City of Detroit. To the extent possible, most of the information was provided to the State.

Today, I received a response from the State (which is attached) indicating that certain accounts were denied and that the remaining funds will be forwarded within 30 to 60 days.

I am awaiting a response from the State on my request for more specifics about the accounts that were denied.
