Q Tell me what took place at the address  
of 4139 Canton

A I picked my Brother up on Gratiot we  
went to the house on Canton, Ray Ray  
Johnny Jones, Wop, myself and my Brother  
Leshard. We and my Brother entered first  
we were let inside my Brother told this  
Guy he was going upstairs to get the  
Gauge. He went up and came back down,  
He gave me the Gauge and checked it for Bullets  
There was two in it the Gauge. My Brother  
Started Talking to somebody. He asked me was  
I ready I was standing by the kitchen door.  
when he asked me. I shot the white Guy  
on the couch in the dining room. I don't  
know what was going on in the front room.  
After I shot the white Guy on the couch  
I shot the Guy who was sitting at the  
kitchen Table, By that time my Brother  
ran to the kitchen with me. My Brother  
Duan Hubbard

Turned and shot the lady who was sitting at the kitchen table with the second guy I shot. By this time we turned and Johnny came in the house as we were walking to the living room because some guys were in the bedroom. We started telling Johnny the guys were in the room. The other guys with us were standing on the porch. Johnny was telling us that we had to kill the guys that were in the room. My brother kicked the door, when he kicked the door somebody had their back on the door, my brother shot into the door once. Johnny shot into the door three times and I shot in the door once with the gauge. My brother kicked the door again IT wouldn't open so we left.

Q- Mr Hubbard were you advised of your Constitutional Rights?

A- yes

Q- Do you have any questions regarding those rights?

A- No

Q- Mr Hubbard do you now wish to give a statement?

A- Yes

Q- Mr. Hubbard What can you tell me about the shootings that occurred at 4139 Canton on 8-18-04?

A- I was over on Canton St. selling crack out of the spot. My shift was over around 8:00 pm so I was ready to go. I used this guys cell phone named Allen who was up in the spot. I called Tom Tom he's the head dude up there that sells dope. I told him that I was ready to go. Tom Tom told me that he had to pick up his wife and that he would be over to get me. A hour and a half had passed so I called him back and asked him was he on his way. He told me he would be there in a little while. Another hour had passed so now it's like 10:30 pm so I called my brother Johnny Jones to come and get me. He told me his truck didn't have any gas so he couldn't come. I told Allen, I was going to give Tom Tom 15 more minutes then I was leaving. 15 mins passed so I left out the spot and walked up towards Gratiot. When I got up to Gratiot my brother Alton Hubbard pulled up in a car and told me to get in. Alton asked me where the guage was that Tom Tom had gave me. I told him that it was over in the spot on Canton St. my brother Alton drove back around to the house on Canton St. we parked in front of the spot and walked up in the house. I told D-Man and Tone that I was going to let my brother use the guage and that I would bring it back

the next day. Tone said ok so I went upstairs and got the gauge from up under the bed and brought it back down. I handed the gun to my brother and he asked was there any shells in it. I told him I think so, there should be one in the chamber for sure. My brother was messing with it and cocked it. One of the rounds fell out so he picked it up and put it back in. ONE of the guys in the kitchen called me in and asked me if I had some shit. I told him just it wasn't my shift. I walked back up to the front, my brother was still in the kitchen. I was talking to D-man, he asked me when was I coming back while I was talking to D-man I saw Tone walk towards his bedroom carrying a gun, it looked like a 9mm. While I was standing there talking to D-man I heard a loud boom come from the kitchen. Me and D-man jumped at the same time. D-man ran towards Tone bedroom. My brother came out the kitchen and shot the white guy that was sitting on the couch in the dining room. I looked at my brother and asked him what the fuck you doing. He looked at me and said "What the fuck you think I'm doing, I'm about to get this broat". He asked me where the other guys went. I told him that they had ran into the bedroom. My brother went over and kicked on the door but they must have been leaning against it. So he just shot through the door, when he kicked it the second time it flew right open. I saw Tone reaching for his gun so I shot at the wall to scare him. Then I ran out the house and up to Grafton. When I got up to Grafton I fell down to my knees and started crying and throwing up. My brother pulled up in the car and told me to get in. He drove me over to my sister house on Iroquois and Grafton dropped me off and left with all the guns.

Q - What type of gun did your brother Alton have?

A - He had a .38 revolver and a 12 gauge shot gun.

Q - What kind of gun did you have?

A - I had a .38 revolver just like his.

Q - Where did you get the gun from?

A - My brother gave it to me right before we went into the house on Canton St.

Q - How many shots did you hear while your brother was in the kitchen?

A - I heard one *D. Altonus Duhard*

Q - Do you know who was inside the house when the shooting occurred?

A - Me, my brother Alton, Tore, D-man his real name is Arthur, the white dude, some guy at the kitchen table smoking crack and some chick that was hiding behind the couch. She should of seen everything.

Q - Did you and your brother Alton discuss robbing the dope spot prior to going over there?

A - No we didn't.

Q - Did you know Alton was going to rob the dope house?

A - No, I didn't.

Q - Why did Alton start shooting people?

A - I don't know, I guess he didn't want to leave witnesses.

Q - Do you know where the guns are now?

A - No.

Q - What Alton get from the robbery?

A - He didn't get nothing, no money, no dope, nothing.

Q - Has Alton robbed any other dope houses?

A - He told me he robbed Tom Tom's other spot over on Glenfield earlier that night.

Q - Were you with him for that one?

A - No.

Q - Why was Alton Robbing Tom Tom spots?

A - I guess he figured since I was working there it would be easy.

Q - Did you shoot anyone?

A - No.

Q - When you got arrested earlier today there was a gun on the back seat next to where you were sitting, was that your gun?

A - Yes

Q - What type of gun was it?

A - A 9mm

Q - Where did you get the gun from?

A - Tom Tom. He was going to sell it to me for \$75. I hadn't paid for it yet. I was actually on my way to give it back to Tom Tom when the police got me.

Q - Did your brother tell you what he did with the guns?

A - No.
