**STIPULATED ORDER AMENDING SCHEDULING ORDER**

Upon stipulation between the Appellants (the “Appellants”) in the above-captioned proceeding (the “Appeal”) and the Detroit Retired City Employees Association (“DRCEA” and, together with the Appellants, the “Parties”) to amend the Scheduling Order for Bankruptcy Appeal (Docket No. 14), the Parties agree to the following with respect to the filing of responsive briefs in the Appeal:

IT IS HEREBY ORDERED THAT:

1. Pursuant to Rules 9006(b)(1) and 8018(a) of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), the deadline for the DRCEA to file its responsive brief in the Appeal is hereby extended to the same date as the deadline for the City to file its responsive brief in the Appeal, as set forth in Stipulation and Order Amending Scheduling Order for Bankruptcy Appeal entered by this Court on February 23, 2015 (Dkt. No. 32).

2. The DRCEA’s responsive brief shall be due on the same day as the City’s responsive brief, including any future extensions or amendments to the deadline for the City’s responsive brief.

3. Pursuant to Rule 8018(a)(3) of the Bankruptcy Rules, the Appellants may serve and file a reply within 30 days after the filing of the DRCEA’s responsive brief, separate from any reply brief that Appellants might file in reply to the responsive brief of the Appellee City of Detroit or any other Appellee.
