AFFIDAVIT OF FREDRICK RELERFORD

BEFORE ME, the undersigned Notary, personally appeared Fredrick Relerford, who being by me first duly sworn, on his oath, deposes and says:

- 1. My name is Fredrick Relerford and I make this affidavit from personal knowledge of the matters addressed herein.
- 2. I participated in the December 18, 2003 attempted armed robbery and murder of Robert Montgomery and the wounding of Darwin McMullen in the City of Flint. The person who committed these crimes with me was Julius McElroy, also known as Dude.
- 3. Before the crime took place, McElroy and I were at my mother's house on Londell and Dayton in Flint smoking weed. We were waiting for McElroy's girlfriend to pick us up, but she never showed.
- 4. McElroy and I started walking toward one of our homeboy's houses on Stockdale Street and Dupont Street. As we were walking, McElroy told me that we needed to find a way to make some fast cash.
- 5. As we were having this conversation, somebody yelled out asking us if we had any weed. McElroy told me, "this is where it starts at", and I didn't know what he was really talking about at the time. I knew he had weed on him, so I thought McElroy was talking about making fast money by selling some weed.
- 6. When we got face-to-face with the guy looking to buy weed, McElroy asked the guy what he was looking for. The guy pulled out a few dollars and was about to say something when McElroy pulled out a gun and told the guy to give him everything he had. McElroy took the guy's phone and turned to look at me. As McElroy was looking at me, the guy ran and got away. McElroy told me that the guy got away because I was acting like a bitch and that next time I needed to "pull my fucking gun".
- 7. We started walking away and when we got to Mt. Elliott Street there was a car parked with two guys sitting in it. McElroy said, "fuck this walking, we need that car". As we walked up to the car, McElroy told me that I was going to drive.

- 8. I walked up to the driver's side and the guy sitting in the driver's seat rolled down the window. I pulled out a .45 pistol and told the driver, "don't fucking move".
- 9. As soon as I told the driver not to move I heard two gunshots go off. I was shocked and the driver of the car had a shocked look on his face. The driver tried to jump out, but I fired a shot into the car and that made him even more scared. The guy reached for my gun, I pulled back, the guy jumped out at me, and I fell on the ground.
- 10. McElroy came around to the driver's side to help. That's when I heard three shots go off. I then started shooting just to make myself look good. McElroy went up to the car and it looked like he was about to pull the dead guy out of the car. I said, "I'm out of this bitch", and took off running. McElroy started running too and we ran all the way to our homeboy's house.
- 11. When we got to the house, McElroy told me to give him my gun and don't say anything to anybody. There was a girl in the house. She called the police and told them that I had killed someone.
- 12. In the days after the shooting all I did was drink, smoke weed and snort cocaine so I wouldn't have to think about what had happened.
- 13. My father eventually turned me into police. All I was thinking about was finding a way out of this.
- 14. The police took me in a room and told me that they knew what happened and that Bay Bay (Glen Vary) was the shooter. From that point on I decided that I would agree that Bay Bay was the person who did it.
- 15. While I was in the county jail, McElroy's girlfriend killed him. I was thinking, "I can't go down for this shit by myself", so I continued to stick with the story that the police told, that Glen Vary was the shooter.
- 16. I knew Vary at the time, but I didn't know him well enough to commit a crime like this one with him. To this day, I don't know how Glen Vary's name came up. Glen Vary was not involved in this crime.
