A review of William Rice's cellular telephone records, the testimony of Art Wimmer, witness statements and 911 call records provides the following timeline:

Rice's telephone records show that on September 17, 2007, at 19:09:03 his cellular telephone is connecting to Metro PCS tower 193, which is located approximately one mile northeast of Davontae Sanford's residence at

The records then show that at 19:09:58 Rice's cellular telephone is connecting to Metro PCS tower 154, located approximately one half mile southwest of Cheryl Sanford's residence at these two residences are located approximately one and a half miles apart. Combining these records with statements by Taminko Sanford, Nathaniel Sanford and Pamela Harris, a timeline would show that William Rice and Nathaniel Sanford picked up Taminko Sanford, Davontae Sanford and Lamaze Sanford at approximately 19:00 hours on September 17, 2007, and drove them to Cheryl Sanford's residence.

Records and witness statements indicate that Davontae Sanford remained at Cheryl Sanford's residence for approximately four hours. Rice's telephone records then show his cellular telephone connecting to Metro PCS tower 193 on September 17, 2007, at 22:52:26. Again, based upon statements by Taminko Sanford, Nathaniel Sanford and Pamela Harris combined with these records, a timeline would show that William Rice and Nathaniel Sanford dropped Taminko, Davontae and Lamaze Sanford back at their residence at approximately 22:52 hours.

Pamela Harris states that in the evening of September 17, 2007, she was at home at 'watching the news when Taminko and Davontae arrived home. She further states that approximately forty-five minutes later she heard gunshots and observed Davontae and Taminko exit their bedrooms.

The 911 Call/Cad Report shows that the initial 911 call of shots fired was received on September 17, 2007, at 23:22. The report then shows a 911 call received from Jesse King at 23:25. The report then shows Detroit Police officers arriving on scene at 23:32 hours.

William Rice's cellular telephone records show he received a telephone call from Dale Collins on September 18, 2007, at 01:39 hours. Combining the records with statements made by Dale Collins it would appear that Sgt Russell and Investigator Collins made contact with Davontae Sanford at approximately 01:30 hours on September 18, 2007.

STATEMENT OF FACTS VINCENT SMOTHERS, ET AL:

The following is synopsis of events surrounding the investigation of Vincent Smothers, and others, for multiple contract killings in the City of Detroit. The following Detroit Police Department Reports are referenced in this synopsis: Incident No. 0701170458; Incident No. 0712260437; Incident No. 0803090032; and Incident No. 0804200152. INTERVIEW OF VINCENT SMOTHERS BY DETROIT POLICE DEPARTMENT:

On April 20, 2008, Smothers was interviewed by Detroit Police Department Sergeant Gerald Williams. During that interview Smothers confessed to several homicides. Specifically, Smothers informed Sgt. Williams that he and an Ernest Davis AKA "Nemo" had committed a contract killing on Runyon Street near State Fair. Smothers explained that the Runyon street homicides were one of several contract killings that were contracted by a Leroy Payne. Smothers stated that Davis had used a .45 caliber pistol and had fired from outside into the house. Smothers further indicated that he had used an AK-47 during the commission of the crime. Smothers explained that a female in the house ran into a back bedroom that had a little boy in it. Smothers stated that he went into the back bedroom and told the female that "everything was all right." Smothers explained that he searched the house and basement while Davis remained upstairs. Smothers stated that he heard gunfire from Davis while he was searching the house. Smothers indicated that the female in the back bedroom and the boy were left in the room. Upon questioning by Sgt Williams, Smothers stated that he took marijuana, approximately two-thousand dollars in cash and a .40 caliber handgun from the residence.

Smothers stated that the homicides on Runyon were committed prior to him committing the homicide of Rose Cobb. Rose Cobb was a Detroit Police Department sergeant's wife. An investigation into that homicide by the Detroit Police Department revealed that Sgt David Cobb had hired Smothers to murder his wife Rose Cobb. Smothers explained that the .40 caliber handgun taken from

1 was the gun he used to murder Rose Cobb.

FIREARMS EXAMINATION BY DEFENSE EXPERT:

The BATF laboratory firearms report states that the thirteen Wolf brand 7.62 x 39mm cartridge cases and the six Federal brand 7.62 x 39 mm cases collected from the crime scene at could NOT have been fired from the same weapon. This would tend to indicate the presence of more than one AK-47 type weapon being used during the commission of the crime. On October 15, 2009, the relevant evidence was submitted to defense firearms examiner David Balash for a separate examination. Balash concluded that the thirteen Wolf brand 7.62 x 39mm cartridge cases and the six Federal brand 7.62 x 39 mm cases could have been fired from the same weapon. However, the Wolf brand cartridge cases lacked sufficient individual markings to allow for a positive identification. Both experts testified in evidentiary hearings on this case. David Balash testified on March 16, 2010 and BATF firearms expert Walter Dandridge testified on July 13, 2010.

SUBSEQUENT STATEMENTS BY VINCENT SMOTHERS:

Smothers has subsequently made several other statements confessing to the homicides that occurred on September 17, 2007, at the residence located at . Smothers provided statements implicating himself and Ernest Davis in an interview with Detroit Police Department Investigator Ira Todd on May 06, 2008; in a statement to State of Michigan Appellate Defender's Officer Investigator Linda Boros; in an affidavit by Smothers dated August 16, 2012; in an interview with Michigan State Police D/Sgt Christopher Corriveau on August 13, 2012; and most recently in an affidavit dated March 06, 2015. Through these interviews and affidavits Smothers provided a much more detailed description of the crime. Smothers indicated that he was hired to kill "Big Mike" by Leroy Payne on behalf of a drug dealer named Delano Thomas. Smothers stated that Leroy Payne directed him to the target house and pointed out the target, Michael Robinson. Smothers explained that he conducted surveillance in the neighborhood noting that Robinson would often sit on his porch and sell marijuana. Smothers stated that the night of the homicides he drove a Jeep Commander and parked on Teppert Street, one street west of Runyon. Smothers stated that he and Davis walked over to the back yard of an abandoned house that was located just north of 19741 Runyon. Smothers explained that he and Davis waited there for a period of time and surveilled "Big Mike's" house.

Smothers stated that he and Davis approached the house and Davis positioned himself in front of a large window in front of the house while he walked up on the porch and checked the front door. Smothers advised that at that time a subject opened the front door and he observed Robinson inside of the residence facing the door.

Smothers stated that he observed Robinson attempt to grab a pistol and he (Smothers) opened fire into the house with an AK-47. Smothers explained that the pistol that Robinson had attempted to grab was the .40 caliber pistol he took from the house. Smothers stated that Davis then opened fire into the house through the window with a .45 caliber pistol. Smothers stated that he and Davis entered the residence. Smothers' description of the events inside of the residence is consistent with those that he had previously described to Sgt Williams.

Smothers also described events when he and Davis left the residence. Smothers stated that he and Davis left the residence and began walking north on Runyon towards State Fair at which time a neighbor began to fire on them. Smothers stated that he returned fire striking the neighbor's house. Smothers stated that he and Davis then walked through a field at the end of the street around to Teppert where they left in his vehicle.

The witness, a Dameitta Barney, stated that she heard gunfire and looked outside and observed a black male firing a gun. Barney further described the shooter as having a fair complexion, approximately 5'8" to 5'10" tall, stoutly built, and possibly having a beard and mustache. Further, the witness stated that the shooter entered a white four door "newer Malibu style bodied car" and left the scene.

A Michigan Secretary of State photograph of Ernest Davis captured on August 22, 2007, shows Ernest Davis wearing a beard and mustache. Additionally, a Detroit Police Department report (0711200041) describes Ernest Davis as a black male, with a light brown complexion, approximately 6' tall and weighing approximately 200 lbs. Further, he is described as having a goatee and mustache.

INTERVIEW WITNESS:

I spoke with Gaskin on 5-14-15 at approximately 1220 hrs via phone. I explained to Gaskin that during the course of our neighborhood canvas her mother Willette Saffold advised me that she was home during this incident and provided me with her phone number.

I asked if she remembered what happened on the night of the quadruple homicide a few houses down from her mother's home in September 2007. She explained that she remembers that night quite well. I then asked her to describe what she remembers.

Gaskin said that she was on the computer when she heard shots. She immediately ran to the living room where her mother was asleep on a chair. She indicated she grabbed her mother and pulled her to the ground. Once the shooting had stopped she remembers looking out the small square window that is in the front door. Gaskin stated she saw a tall man wearing a dark trench coat walking north along the side walk. She said that he was walking like he was carrying a weapon. When I asked how she would know that she said because I grew up in the neighborhood and know how people walk. This subject was walking like he had something. She said he was not wearing a hat nor was he running. As the subject got closer to her home he started to walk through their yard toward the open field/ vacant lot to the north of their home. She said when the subject started walking through her yard she layed back down on the floor so she would not be seen by the subject, as she feared that if she was seen she might be hurt somehow. Gaskin also described the subject as not being heavy set nor was the subject a child. She only saw one subject and could not tell if the subject had anything covering his face. She said it was very dark out at the time of this incident.

INTERVIEW KING:

During the neighborhood canvass of Runyon on May 13, 2015, we contacted one of the original witnesses from 2007, Jesse King. King (aka "Bishop") agreed to come to the Metro Post for a recorded interview on Thursday May 14, 2015. King provided information that was consistent with the information he had provided to investigators in the past. The below is a summary of his information. See recorded interview for details.

King advised he was living at in 2007 when the homicide occurred. He advised he and his son were watching television in the living room just prior to the event. He stated he got up to go pick up his wife who worked a night shift. As he prepared to leave, he heard gunshots from the direction of the scene. King opened the front door to see what the source of the gunfire was, and observed two males walking northbound on Runyon on the west side of the street across from his house. King advised there was an extremely thick fog blanketing the street that night, making it difficult to see the two subjects. He advised that they were wearing long dark coats, but he was unable to provide any further description.

King indicated he did not believe that either subject was Davontae Sanford. He explained that he knew Sanford because he (King) used to volunteer at the local school where Sanford was a student. He advised Sanford was also well known in the neighborhood. King thought Sanford may have been affiliated with a criminal gang the "Bloods" or the "Crips" because he often saw Sanford wearing the color red. He could not remember which gang however. King stated he was familiar with Sanford's walk and neither subject that night appeared to move like Sanford. He continued that, almost as soon as he opened his door, the subjects began shooting at him. King advised he had his pistol with him and he shot back at them. He advised he was not injured in the exchange and he did not think he injured either suspect. See recorded interview for further details.
