AFFIDAVIT / STATEMENT OF FACTS

I Masada King, being first duly sworn and says: That I MASADA King and I making this affidavit / statement of facts and depose freely and under no-compulsion or coercion.

1) I am stating the facts about an attempted murder that I committed.

2) I state that on the night in of the attempted murder, I MASADA King and my two friends Rick and Terry were smoking weed, drinking liquor, and hanging out.

3) We ended up going to a few gentlemen's clubs that night, in which one of the clubs were on Eight Mile and Hubbell called "All Stars", then we headed to "MANDEES" on Six Mile and Ryan.

4) Our means of transportation was a white four door Buick that I rented from a drug user, in which we traveled in all night.

5) At about 11:30 p.m. we arrived at "Mandees", upon entering the club and settling down I recognized Antonio Davis and a few more guys who are related to him from the neighborhood, I think their names were Dwayne, A.Sonis, and Joe.

6) I met Antonio Davis AKA "T.D."; through his cousin Ron Davis who was a close friend of mine, he was killed in November of 2001 which was a month before this incident.

7) Ron Davis lived on Makay with his grandmother (Jackie) and his brother (Tebby) & sister (Rhondalya), their house was between Six Mile and Davissaw in which was one block away from where he was killed.

8) After leaving "Mandees", me, Rick and Terry drove the Buick to a club called "Pages" on Degondie, Antonio Davis drove a white Ford Van 1993 version.

9) Antonio Davis and his cousin's exited the van and entered into the club "Pages"; me and my friend's Rick and Terry also entered the club and proceeded to consume several drinks.

10) Approximately 30 minutes later a group of guys started staring at us and a verbal exchange ensued, afterwards the other group of guys left the club and then Antonio Davis told me that he had an "A-K 47" and a 9MM semi auto pistol in the van.

11) Antonio Davis let me and Rick and Terry know that the guys who we had the verbal altercation with, were from his neighborhood and believed to be the guys who killed his cousin Ron.

12) When the bar was approaching closing time around 1:35 a.m., I Masaba King told everyone that I was with ~~Ed~~ go outside to make sure that everything was alright.

13) Antonio Davis gave me the keys to the van, and I then proceeded outside club "Pagns" to the van and retrieved the "A-1 Assault Rifle".


14) I walked back to the entrance of the bar, and told Antonio Davis and the rest of the guys let's go when I was approached by an older woman asking me if everything was alright, then Rick, Terry, Dwayne, and Antonio exited the club.

15) We all walked to the van and everyone were getting in, as I was entering the van door I witnessed a black car with someone pointing a gun toward us.

16) I Masaba King, then turned around and began shooting the assault rifle at the black car, I fired between six to eight shots then I began to run to

my car which was parked on the street behind the bar. I wiped off the assault rifle, then I proceeded to a trash dumpster in which I threw the assault rifle inside, and then I ran to the white Buick that I rented and pulled off.

I swear under the penalty of perjury to the actions that I Masaba King took on _____, that are listed above are true and correct to the best of my knowledge, information and belief.
