1. ON SEPTEMBER 1, 2015, I RECEIVED A HANDWRITTEN LETTER FROM VINCENT SMOTHERS INMATE NUMBER 295527 WHILE INCARCERATED AT THE MACOMB CORRECTIONAL FACILITY LOCATED AT 34625 26 MILE ROAD, NEW HAVEN, MICH. 48048.

2. THE LETTER HAD A RETURN ADDRESS OF 19215 ELKART, HARPER WOODS, MICH. 48225. (EXHIBIT (1) LETTER AND ENVELOPE POST MARKED AUGUST 23, 2015.

3. VINCENT SMOTHERS AT THE TIME WAS INCARCERATED IN LEVEL 4, AT ALGER CORRECTIONAL FACILITY, 6141 Industrial Park Drive, Muskegon, Mich. 49862

4. VINCENT SMOTHERS WAS TRANSFERRED TO MACOMB CORRECTIONAL FACILITY IN DECEMBER 2015.

5. SMOTHERS PRODUCED A SIGNED AFFIDAVIT, WHILE IN LEVEL 4.

6. I HAVE ANOTHER AFFIDAVIT FROM PRISONER LOVE JOY, WHO SMOTHERS ADMITTED HIS INVOLVEMENT IN THIS CASE TO WHILE IN LEVEL 4, AT MACOMB CORRECTIONAL FACILITY.

7. ON FEBRUARY 23, 2016 SMOTHERS WAS TRANSFERRED FROM LEVEL 4 TO LEVEL 2, HOUSING UNIT 2 WHERE I WAS HOUSED, IN CELL 45-T

8. UPON SMOTHERS ARRIVAL INTO THE UNIT, I SPOKE WITH A UNIT OFFICER, WHOM I SHOWED THE AUGUST 22, 2015 LETTER TO WHEN I RECEIVED IT IN SEPTEMBER 2015.

9. AFTER LETTING THIS SAME OFFICER KNOW, THAT THE GUY WHO CONFESSED TO MY CASE, WAS NOW IN THE HOUSING UNIT.

10. THE OFFICER ASKED WOULD IT BE A PROBLEM?

11. I SAID NO, BUT I WAS LATER TRANSFERRED TO THE CHIPPEWA CORRECTIONAL FACILITY ON MAY 5, 2016.
