Charter County of Wayne, Municipal Ordinance:

Chapter 73 – FRAUD INVESTIGATION POLICY

Sec. 73-1. - Purposes.

(3) To place all elected and appointed officials, directors, officers and employees of the county **ON NOTICE** that wrongdoing of a criminal nature must be reported directly to the county **prosecutor**. Supervisors shall be advised of those reports, except when appropriate.

Sec. 73-2. – ACTION required.

(5) All acknowledgements obtained shall be placed in individual personnel files and shall be retained permanently.

PUBLIC EMPLOYEES

Through this abusive legal process public employees are "Impersonating a 'Peace Officer'/Law Enforcement Officer and (Re) presenting as a County Deputy Sheriff and Auctioneer. There are No wet ink signatures, Employees are using Rubber Stamp signatures, and Wayne County Notaries are not identifying (gender) ("She" NOT a "He")

These fraudulent documents are then filed in the City Department of Assessment; <u>Affidavits</u> are <u>unlawfully</u> filed <u>without the owner's signature</u> transferring the land to an unlawful <u>buyer</u>, <u>with no tax assessments</u>. <u>Affidavits</u> are being <u>signed</u> by the Law Firm Attorneys as the Owner.

THE FORECLOSING LAW FIRMS, ATTORNEYS, STATE and FEDERAL JUDGES:

FRAUDULENT FORECLOSURE COMPLAINTS & SUMMONS – <u>Filed in the County Clerk Offices</u> <u>under false pretences to invoke jurisdiction</u>. **FACT**: No factual witness, proof of standing or interest, or injured party are present before the judges in any court; residents are forced to pay into bogus escrow accounts; Courts cannot provide verification of proof of any deposit into any bank, and judges just give the escrow to the attorneys. Is this intentionally done so that Wayne County benefits financially from the fraudulent documents?

ROBO SIGNING

This is done by duplicating foreclosure documents using <u>Initial Signatures of a County Public Notary(ies) on the Foreclosure Notice Affidavits for Publication & Evidence of Sale.</u> Law Firm's and their Attorneys are executing and submitting false legal documents in court without ensuring their accuracy. The judges are not allowing the Owners due process to challenge the false legal documents.

DUAL TRACKING

Foreclosing law firms are foreclosing on the People knowing they are in a "lawful" Modification Agreement at the same time as the Foreclosure Process.
