DETAILS OF INCIDENT:

Mr. Green, who contacted the station by telephone, states the following occurred on today's date at approximately 9:15pm:
 Mr. Green was stopped by police at Annabelle/Schaefler. He was driving his 1994 Buick & was in the company of another male & female (he refused to provide their names, when asked, until he talked with his attorney). He says a uniform officer ordered him from the vehicle & began to search his person. He says ~~that~~ officer, identified as Michael Osman, badge 4788, put his hand down the front & back of his pants several times & at one point in his buttocks hole. Mr. Green stated he was then released but not ticketed. He stated he is upset at the intrusiveness of the search & further stated he was searched for no reason at all. The other officer was identified as Michael Parish, badge 4436. Both officers were working SW-71.
