## **EXECUTIVE SUMMARY**

The Detroit Department of Transportation (DDOT) announced it will implement a series of route adjustments and alternatives identified to help the transit system improve operational efficiencies and service reliability. The service changes, effective March 3, 2012, will help to move DDOT toward operations that are consistent with its budget, and will help to provide fare stability for its customers.

DDOT encourages the public to attend any morning and evening public hearing to obtain maximum customer awareness on the new service changes. Locations, dates and times are displayed within the document.

In addition, this document contains the affected service changes in detail, categorized as eliminations, route restructuring, reroutes and weekday and weekend service changes.

DDOT is working toward the goal of providing more customer-friendly and reliable, on-time performance. We know our customers deserve quality transportation to destinations of choice, and we will be successful in achieving this essential goal.

# **WEEKDAY SERVICE CHANGES**

Affected routes for Weekday bus service follow:

## Route 7 - Cadillac-Harper
