EMA Group proposed 81 percent cut to DWSD workforce



## Ficano's ex-appointees get six-figure jobs at Detroit water department

Former appointees of Wayne County Executive Robert Ficano who are looking for new jobs could do a lot worse than applying at the Detroit Water and Sewerage Department.

In the past eight months, three of Ficano's former top aides have landed six-figure jobs with department, which serves more than 4 million customers in southeast Michigan.

The latest is William Wolfson, Ficano's former assistant deputy CEO, who was hired June 25 to be general counsel. The job is newly created and pays \$132,500 annually. Previously, City of Detroit lawyers handled the legal work. . .

Wolfson joins Matthew Schenk, who was hired in March as chief operating officer and is paid \$194,000 a year. In November 2011, the Board of Water Commissioners approved a \$100,000, 1-year financial consulting contract for Butler Benton, Ficano's former director of environment.

"We should all be concerned that the Detroit Water and Sewerage Department not become fertile ground for ex-Ficano appointees who want lucrative positions," said state Rep. Kurt Heise, R-Plymouth Township, who has sponsored a bill to place management of the department under a regional authority. Heise also worked for Ficano and knows all three men. Wolfson retired from Wayne County in 2009 with a pension that pays him about \$118,000 per year. Benton retired in 2011 with an \$80,000/yr. pension.

Schenk, 40, was one of several Ficano appointees given a special retirement incentive last year. Under the deal, he could qualify for a pension paying at least \$83,000 annually and potentially far more if he buys into the plan at a discounted rate.

Schenk told the Free Press in March that he has no plans to collect it vet because of his age.

Water department spokeswoman Mary Alfonzo said Wolfson's job was filled through a lengthy process. "Applicants were sought, interviews were conducted," she said, "I know that it was posted on our website." Wolfson didn't return a call seeking comment on his new post.

Oakland County Water Resources Commissioner John McCulloch, who was highly critical of Schenk's hiring, said Wolfson's was different because the job was posted statewide and water commissioners were in on the hiring.

"There is always a perception that you have all these 'Wayne County' people," McCulloch said. "This one, they went through the process."
