## **CALL FOR A MASS RALLY! JUSTICE FOR TIM AND MALISSA March 1, 2013**

---

**MARCH 1, 2013**

**Cleveland, Ohio**— On November 29, 2012, beginning at approximately 10:30 p.m., 30 year old Malissa Williams and 43 year old Timothy Russell were chased by 62 police cars and 115 police officers until they were boxed in by Heritage Middle School in East Cleveland and slaughtered like animals in a trap. During the chase and at the point of execution, there were 137 shots fired into the couple, into their car and into other police cars. Only 13 of those officers felt their lives were in danger enough to fire 24 bullets into Malissa and 23 into Tim at almost point blank range! One officer who felt his life was in danger jumped on the hood of the car where two people he believed to be alive and believed had a gun and fired 49 rounds at point blank range!

The 50 + member organizations of the Task Force for Community Mobilization will be leading a mass protest on Public Square on Friday March 1, 2013. We are calling on all interested citizens who want to see justice served to join us. Bring your signs and banners. We want justice! Assembly will be at 4:30 pm. and the rally will begin at 5:00 p.m.

We are asking for the charges to be brought against the officers involved and let them have their day in court—a process they denied Tim and Malissa. Failure to stop for a police officer is not a death penalty offense. We want answers! Why so many cars! Why so many officers! Why are these officers not facing charges! We will continue our demand for an independent prosecutor in this case! This time of slaughter cannot be allowed! This time it was Tim and Malissa—next time, it could be your son or daughter!
