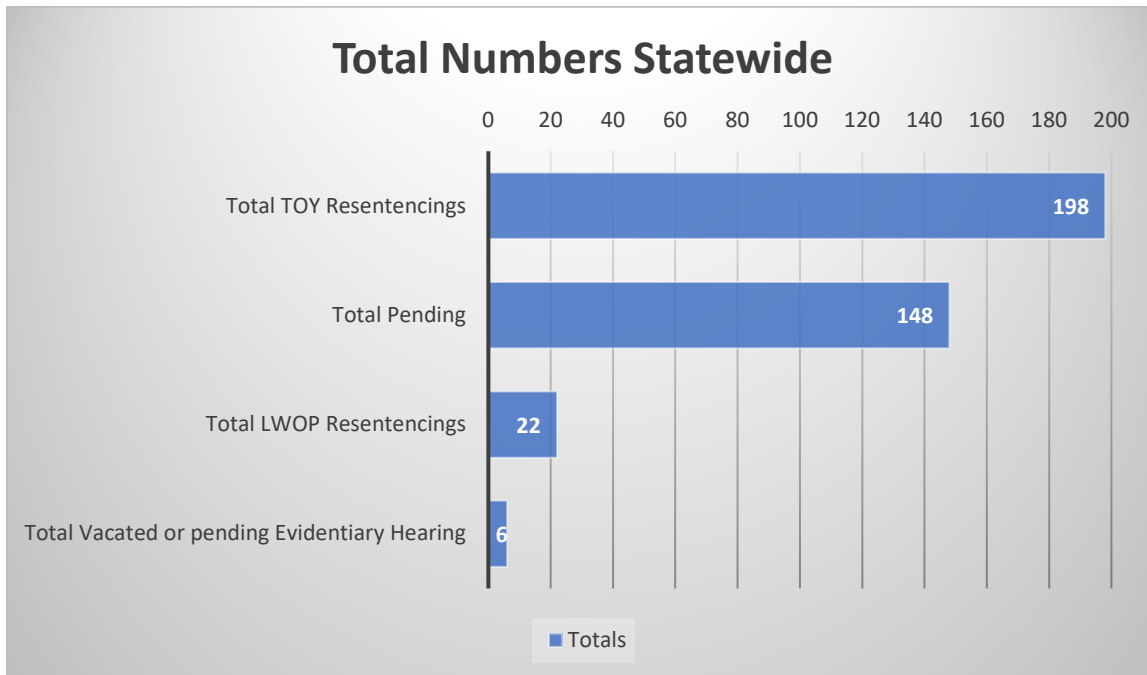

Michigan Juvenile Lifer Re-Sentencing Hearings after *Montgomery vs. Louisiana* and *Miller vs. Alabama*

To date, Michigan courts have held 220 re-sentencing hearings for former “juvenile lifers.” Courts have imposed 198 term of years (TOY) sentences and 22 life without parole (LWOP) sentences. Of the 22, four have been vacated on appeal, two more await evidentiary hearings ordered on appeal, and most others await appellate court decisions.

Many of the TOY sentences were imposed pursuant to agreement between parties, but a number stem from contested sentencing hearings, where judges have denied the prosecution motion for a life without parole sentence in the majority of cases.

Macomb County: 13 cases, 6 resentenced to a TOY, 2 resentenced to LWOP, **1 case vacated on appeal, and new trial and sentencing ordered,** remainder pending

Midland County: 2 cases, 1 resentenced to a TOY, 1 resentenced to LWOP

Montcalm County: 1 case, pending resentencing

Muskegon County: 7 cases, 1 resentenced to TOY, remainder pending (but with TOY offers in four cases)

Newaygo County: 1 case, resentenced to TOY

Oakland County: 48 cases, 17 resentenced to TOY, 3 resentenced to LWOP (including one “volunteer”)

Osceola County: 1 case, resentenced to TOY

Ottawa County: 1 case, resentenced to LWOP

Saginaw County: 21 cases, 11 resentence to TOY, 1 resentenced to LWOP

Shiawassee County: 4 cases, 2 resentenced to TOY, 1 resentenced to LWOP, 1 TOY resentencing pending

St. Claire County: 4 cases, 1 resentenced to TOY, 1 resentenced to LWOP, remainder pending

St. Joseph County: 2 cases, 2 cases resentenced to TOY

Van Buren County: 2 cases, 2 cases resentenced to TOY

Washtenaw County: 7 cases, 7 cases resentenced to TOY
