

TEXT OF THELONIOUS SEARCY'S LETTER TO DPD CHIEF JAMES CRAIG

THE HISTORY OF THE (PEOPLE V.THELONIOUS SEARCY).(04 12890-FC)

ON MAY 9,2005 ,INSIDE OF (FRANK MURPHY HALL OF JUSTICE) ,THELONIOUS SEARCY WAS FOUND GUILTY ,FOR THE MURDER OF JAMAL SEGARS AND THE ASSAULT WITH THE INTENT TO MURDER OF BRIAN MINNER.THIS INCIDENT OCCURRED ON (9-5-2005) ON DETROIT'S (NORTHEAST) SIDE,OUTSIDE A PARTY BEING HELD AT THE DETROIT CITY AIRPORT. ON CONNERS &WITHORN....

ACCORDING TO COURT DOCUMENTS IN PEOPLE VS SEARCY.MR.SEARCY WAS KNOWN ON THE STREETS OF DETROIT AS"SKINNYMAN"WAYNE COUNTY PROSECUTOR PATRICK MUSKAT,(P51482),BELIEVED I WAS INVOLVED IN A ONGOING DISPUTE WITH INFORMANT DEANTHONY D-ANT WITCHER. ON SEPTEMBER 9,2004. FOUR DAYS AFTER THE MURDER OF SEGARS AND THE SHOOTING OF MINNER, INFORMANT WITCHER,WAS APPREHENDED BY HOMICIDE DETECTIVE COLLINS BROUGHT INFORMANT WITCHER ,TO POLICE HEADQUARTERS, WHERE COLLINS SOLICITED INFORMATION WITCHER ABOUT THIS SHOOTING THAT OCCURRED ON NOVEMBER 13,2003, ON SPRING GARDEN AND CHALMERS. AFTER INTEROGATING WITCHER ABOUT THIS WITCHER WAS QUESTIONED ABOUT THE SHOOTING OF BRIAN MINNER AND THE MURDER OF JAMAL SEGARS.WITCHER TOLD INVESTIGATORS THAT HE HAD BEEF WITH A GUY NAMED "SKINNYMAN". AND HE BELIEVED I COMMITTED THE SHOOTING AT THE AIRPORT. UPON RECEIVING THIS INFORMATION FROM INFORMANT WITCHER, DETECTIVE COLLINS, TOOK THIS INFORMATION TO THE WAYNE COUNTY PROSECUTORS OFFICE, WHERE PROSECUTOR PATRICK MUSKAT REQUESTED A MURDER WARRANT FOR MY ARREST,ON SEPTEMBER 6,2004.ON NOVEMBER 30,2004,TWO MONTHS AFTER THE WARRANT WAS ISSUED FOR MY ARREST,MEMBERS OF THE VIOLENT FUGITIVE TASK FORCE & THE F.B.I.,ARRESTED ME AT MY GRANDMOTHER'S APPARTMENT IN CLINTON TOWNSHIP, MICHIGAN. DURING MY ARREST ,POLICE RECOVERED A FIREARM AND ARRESTED MY WIFE FOR OBSTRUCTION OF JUSTICE. WHILE I WAS PREPARING FOR TRIAL,AT THE WAYNE COUNTY JAIL @570CLINTON STREET IN DETROIT, DEANTHONY 'S UNCLE HARVEY WITCHER,PERFECTED A SWORN AFFIDAVIT STATING WITNESS LATASHA BOATRIGT AND KIMBERLY JEFFERIES STRINGER,WERE PAYED BY HIS NEPHEW DEANTHONY WITCHER TO TESTIFY AGAINST ME.HARVEY WITCHER GAVE THIS INFORMATION TO STATE INVESTIGATOR JOHN GOODSON,FROM IVERSON INVESTIGATIONS,ON 4-19-2005,WHILE ON A WRIT FROM LAKELAND CORRECTIONAL FACILITY .(SEE AFFIDAVIT FROM HARVEY WITCHER) INMATE#149304.BEFORE TRIAL AT EVIDENTIARY HEARING ON 4-20-2005,CHIEF JUDGE TIMOTHY MICHAEL

KENNY,MADE IT CLEAR TO MY ATTORNEY (ROBERT MITCHELL)(P17838)THAT HE DIDN'T WANT HARVEY WITCHER TO TESTIFY ON MY BEHALF AS A WITNESS.READ PEOPLE VS SEARCY TRIAL TRANSCRIPT FROM THIS HEARING ON (4-20-2005) PAGES (13&14)ONE OF TH MOST QUESTIONABLE THINGS THAT TRANSPIRED IN MY CASE IS INFORMANT WITCHER'S INVOLVEMENT IN THE SEGARS AND MINNER CASE .INFORMANT WITCHER WAS ALLOWED TO TESTIFY ABOUT AN UNCHARGED ALLEGED SHOOTING THAT TOOK PLACE WITH HIM.UNDER A HIGHLY PREJUDICED CASE LAW CALLED 404 B.WHICH DEALS WITH PREVIOUS BAD ACTS. PROSECUTOR PATRICK MUSKAT WAS ALLOWED TO ESTABLISH A 1STDEGREE MURDER CHARGE AGAINST ME UNDER THIS CONTROVERSIAL CASE LAW.WHAT'S EVEN MORE SHOCKING IS THE FACT THAT CHIEF JUDGE TIMOTHY KENNY ADMITS THAT THIS CASE LAW WAS PREJUDICIAL TOWARDS ME AT THE EVIDENTIARY HEARING HELD ON 4-20-2005:PAGE# 12."BUT IN THIS CASE CERTAINLY THERE IS SOME PREJUDICE, BUT IS IT OUT WEIGHED BY THE PROBATIVE VALUE? THE ANSWER IS NO! PROSECUTOR MUSKAT ALLOWED DEANTHONY WITCHER TO LIE TO SKINNYMAN'S JURY ABOUT NOT BEING INVOLVED IN NO CRIME(READ TRIAL TRANSCRIPT FROM MAY 3,2005 PAGE #88.IN 2014 MY FAMILY F.O.I.A. MY HOMICDE FILE AND DISCOVERED THAT DEANTHONY WITCHER HAD BEEN ARRESTED FOR CARRYING A LOADED FIREARM ON EAST 8MILE RD AND HOOVER,FOR DRIVNG WITH A LOADED 9MM FIREARM INSIDE OF HIS 1998 BLUE CORVETTE. MYSELF NOR MY ATTORNEY HAD KNOWLEDGE ABOUT THIS INFORMATION. THE PROSECUTOR HAD KNOWLEDGE ABOUT THIS FIREARM, BUT FAILED TO DISCLOSE THIS TO MY ATTORNEY .WHAT'S EVEN MORE SUSPICIOUS IS WITCHER HAS NEVER BEEN CHARGED WITH THIS FIREARM. PROSECUTOR MUSKAT DISCLOSED TO THE JURY THAT INFORMANT WITCHER WAS GIVEN A DEAL UNDER (USE OF IMMUNITY) FOR 3 POUNDS OF MARIJUANA THAT HE HAD IN HIS POSSESSION WHEN HE WAS ALLEGEDLY SHOT.THIS PROSECUTOR NEVER DISCLOSED THAT WITCHER RECEIVED A DEAL FOR THE FIREARM. DETECTIVE COLLINS WAS REPRIMANDED FOR HIS CORRUPT TACTICS AND PRACTICES IN THE DTAGNET SCANDAL FOR FORCING WITNESSES TO TESTIFY AND TAKE IMMUNITY. THIS SAME TACTIC WAS USED IN MY CASE. THROUGHOUT THIS CASE,ITS A HOST OF VIOLATIONS FROM MY ATTORNEY ,THE CHIEF JUDGE&PROSECUTOR MUSKAT.IF POLICE REPORTS WERE HIDDEN,WHAT ELSE TOOK PLACE?WHY WAS I THE ONLY SUSPECT PURSUED IN THIS CASE?.11 YEARS AFTER MY ARREST DETROIT HITMAN VICENT SMOTHERS,CONTACTED ME CONFESSING TO THE MURDER OF JAMAL SEGARS&THE SHOOTING OF BRIAN MINNER.HE SENT THIS INFORMATION ON AUGUST 22,2015 .SMOTHERS HAS CONTACTED THE MEDIA&PROVIDED A MAP IN SUPPORT TO HIS LETTER .SMOTHERS CO-DEFENDANT IN THE ROSE COBB SLAYING ALSO PROVIDED A AFFIDAVIT.
