They try to kick in the bedroom door. I am blocking the lower part of the door with my feet leaning on the bed. They start firing shots into the room. They leave out & shot through the window. The white guy says don't shoot me & I then heard scream in shot. Gage & his cousin then leave.

A) Stocky, Blk 20, 6'0", 200lbs med comple, with braids, mustache, Blk shorts, Blue shirt, white shoes
